remain a member, the casual vacancy so created shall be filled as soon as practicable thereafter by the appointment or election of a member in the manner in which the vacating member was appointed or elected, and the member appointed or elected to fill the vacancy shall hold office for the residue of the term of office of the member whom he replaces he replaces.

(4) The powers of the Board shall not be affected by any vacancy in the membership thereof.
