### CHARITABLE TRUSTS ACT 1957

THE John Millar Trust Board has applied to the Supreme Court at Auckland for approval of a scheme under the above statute. The scheme submitted to the Court proposes an amendment to the objects of the trust created by the will of the late John Millar, of Auckland, retired, so that all persons and churches who were eligible as beneficiaries under the trust prior to the passing of resolutions by the Assembly of the Congregational Union of New Zealand in October 1969, should remain eligible as beneficiaries under the trust. Pursuant to the resolutions referred to, a number of the churches of the Congregational Union of New Zealand and a number of the ministers of that church became member churches and ministers of the Presbyterian Church of New Zealand.

New motion for approval of the scheme is for hearing in the Supreme Court at 10 a.m. on Monday, the 17th day of September 1973. Any person desiring to oppose this scheme is required to give written notice of his intention to do so to the Registrar of the Supreme Court at Auckland and to the John Millar Trust Board and to the Attorney General, not less than 7 clear days before that date.
