Notice of Age Groups Appointed by the Minister for the Purpose of the Social Security (Dental Benefits) Regulations 1960

- Those persons who, in the last term of the immediately preceding calendar year, were enrolled in any class of a primary or intermediate school or department:
- Those persons who, not being persons referred to in paragraph (a) hereof, are for the time being under 16 years of age:
- All other persons who are for the time being under 18 years of age, and in respect of whom a family benefit is for the time being payable under section 32 of the Social Security Act 1964 or would be so payable were it not for the provisions of subsection (2) of that section.

The notice of age groups dated the 27th day of January 1947 and published in *Gazette*, 1947, Vol. I, at page 89 is hereby revoked.
