## ORDER OF PRECEDENCE IN NEW ZEALAND

1. His Excellency the Governor-General, or (whilst acting in the place of the Governor-General) the deputy of the Governor-General or the officer administering the Government.
2. The Prime Minister.
3. The Speaker of the Parliament of New Zealand.
4. The Dean of the Diplomatic Corps.
5. The Deputy Prime Minister and Ministers of the Crown.
6. The Chief Justice.
