

## HAWKESBURY-SILVERPEAKS WARD

ALL that area in the Otago Land District, Counties of Taieri, Waihemo, and Waikouaiti and Borough of Waikouaiti, containing 62 300 hectares, more or less, bounded by a line commencing at Trig. S, Swampy Spur, Block V, Dunedin and East Taieri Survey District, and proceeding generally westerly and north-westerly along the southern and south-western boundaries of the East Otago Pest Destruction District to the confluence of the Taieri River and Deep Stream; thence generally north-westerly along the middle of the Taieri River to a point in line with the southernmost boundary of Block VII, Nenthorn Survey District; thence westerly to and along that boundary and the southern boundary of Block VIII and the production of the last-mentioned boundary to the middle of Three O'clock Stream; thence generally north-easterly along the middle of that stream to a point in line with the eastern boundary of Section 9, Block VIII, Silverpeak Survey District; thence northerly to and along that boundary to the southern boundary of Section 1, Block IX, Hummock Survey District; thence generally north-westerly along the north-eastern boundary of Section 1, Block IX, Sections 2 and 1, Block VII, to the northern boundary of the last-mentioned section; thence north-easterly along the north-western boundary of Section 1, Block VI, and Run 171D to the western boundary of Run 171E; thence southerly and easterly along the western and southern boundaries of that run and the production of the last-mentioned boundary to the middle of the Waikouaiti River (North Branch); thence generally south-easterly along the middle of that river to a point in line with the eastern boundary of Part Lot 9, D.P. 1935; thence southerly to and along that boundary to the north-eastern side of Island Road; thence generally south-easterly along the north-eastern side of that road to the north-western side of Mount Watkin Road; thence north-easterly along the north-western side of that road to a point in line with the southern boundary of Part Lot 7, D.P. 2194; thence easterly to and generally easterly and northerly along the southern and eastern boundary of that Part Lot 7 to the south-western side of an un-named road; thence north-westerly along the south-western side of that road to a point in line with the eastern boundary of Part Lot 8, D.P. 2194; thence northerly to and along the eastern boundary of that Part Lot 8 to the southern side of Mount Trotter Road; thence generally easterly along the southern side of that road to its intersection with the north-western side of Mount Pleasant Road; thence north-westerly along a right line to the north-eastern corner of Lot 1, D.P. 9634; thence generally westerly along the southern side of Taieri Peak Road to the western side of Boundary Road; thence southerly along the western side of that road and easterly along the southern side of Hudson road to the north-eastern side of an un-named road in Block IV, Moeraki Survey District; thence generally south-easterly along the north-eastern side of that road to the right bank of Stony Creek; thence generally easterly along that right bank to the mean high-water mark of the sea; thence generally south-westerly along the mean high-water mark of the sea to the right bank of the Waikouaiti River; thence generally north-westerly along that right bank and its production to the middle of the Waikouaiti River (South Branch); thence generally south-westerly along the middle of that river to a point in line with the southern boundary of Lot 5, D.P. 11332; thence easterly to and along that southern boundary to the eastern boundary of Block I, Waikouaiti Survey District; thence southerly and easterly along the western and southern boundaries of that Block I to the western boundary of Block I to the western boundary of Block II, North Harbour and Blueskin Survey District; thence generally south-westerly and south-easterly along the north-western and south-western boundaries of that Block II to a point in line with the north-western boundary of Section 28, Block III; thence south-westerly to and along the north-western boundaries of that Section 28 and Sections 27, Part 26, Part 24 and 15 and Lots A, B, and Part C, D.P. 1299, Block III, aforesaid to the point of commencement.

## TAIERI RIDGE WARD

ALL that area in the Otago Land District and Counties of Maniototo, Waihemo, and Taieri, containing 63 450 hectares, more or less, bounded by a line commencing at the westernmost corner of Run 712, Block V, Rock and Pillar Survey District, and proceeding generally north-easterly and easterly along the generally north-western and northern boundaries of the East Otago Pest Destruction District to Trig. K, Flat Hill, Block IV; thence easterly and generally south-easterly and southerly along the northern, generally north-eastern and eastern boundaries of Sections 1 and 2, Block IV, aforesaid, to the north-western corner of Section 2, Block IV, Highlay Survey District; thence easterly along the northern

boundary of Section 2, aforesaid, and its production to the eastern side of Matheson Road; thence generally south-westerly along the north-eastern and south-eastern sides of Matheson Road and the Scorgie Road to the north-western boundary of Section 14, Block I, Budle Survey District; thence generally south-westerly along the north-western boundaries of Sections 14, 26, 15, and 16, Block I, and along the eastern side of a road intersecting Section 1, Block III, Strath Taieri Survey District, and along the north-western boundaries of Sections 18, 1, and 2 Block VII, Strath Taieri Survey District, to the south-western corner of Section 2, aforesaid; thence easterly along the northern boundaries of Sections 3 and 14, Block VII, aforesaid, and the production of the last-mentioned boundary to the western boundary of Block VI, Budle Survey District; thence generally southerly along the western boundary of that Block VI and Block I, Hummock Survey District, to the northernmost corner of Section 4, Block I, aforesaid; thence south-easterly along the north-eastern boundary of that Section 4, to the north-western boundary of Run 121; thence south-westerly along that boundary to its westernmost intersection with Nenthorn Creek; thence generally south-easterly along the middle of Nenthorn Creek to the south-western boundary of Run 121; thence south-easterly along that boundary and the south-western boundary of Run 121A to the north-eastern corner of Section 1, Block VII, Hummock Survey District; thence generally southerly along the eastern boundaries of Sections 1 and 2, Block VII, and Section 1, Block IX, Hummock Survey District, and Section 9, Block VIII, Silverpeak Survey District and the production of the last-mentioned boundary to the middle of Three O'clock Stream; thence generally south-westerly along the middle of Three O'clock Stream to a point in line with the southern boundary of Section 3 Block VIII, Menthorn Survey District; thence westerly to and along that boundary and the southern boundary of Section 2, Block VII, Nenthorn Survey District, and its production to the middle of the Taieri River; thence generally north-westerly along the middle of the Taieri River to a point in line with the north-eastern boundary of Part Run 713; thence north-westerly to and along that boundary, north-easterly along the south-eastern boundary, and north-westerly along the north-eastern boundary of Part Run 713 to the point of commencement.

## STRATH TAIERI WARD

ALL that area in the Otago Land District, Taieri and Maniototo Counties containing 85 850 hectares, more or less, bounded by a line commencing at the confluence of the Taieri River and Deep Stream in Block XI, Nenthorn Survey District and proceeding generally westerly, south-westerly, north-westerly, and north-easterly along the western south-eastern, south-western, and north-western boundaries of the East Otago Pest Destruction District to the north-eastern boundary of Part Run 713; thence south-easterly along that north-eastern boundary, south-westerly along the south-eastern boundary, and south-easterly along the north-eastern boundary, and the production of the last-mentioned boundary to the middle of the Taieri River; thence generally south-westerly and south-easterly along the middle of that river to the point of commencement.

## MACRAES WARD

ALL that area in the Otago Land District, Counties of Maniototo, Taieri, Waihemo, Waikouaiti, and Waitaki, containing 65 800 hectares, more or less, bounded by a line commencing at Trig. K, Flat Hill, Block IV, Rock and Pillar Survey District, and proceeding generally north-easterly, south-easterly, easterly, and south-westerly along the north-western, north-eastern, northern, and south-eastern boundaries of the East Otago Pest Destruction District to the easternmost corner of Lot 2, D.P. 11132, Block XV, Moeraki Survey District; thence south-westerly along the north-western side of Sweetwater Creek Road to the southernmost corner of Part Section 9, Block XV, aforesaid; thence south-easterly to and along the north-eastern boundary of Part Section 4, Block XV, aforesaid, and southerly along the eastern boundary of that section to its southernmost corner; thence north-westerly along the north-eastern boundary of Part Section 5, Block XV, aforesaid, and south-westerly along the north-western boundaries of that part section, Part Section 3, Block XV, aforesaid, and Part Sections 2 and 1, Block VIII, Moeraki Survey District, and the production of the last-mentioned boundary to the middle of the Shag River; thence generally westerly along the middle of that river to a point in line with the southern boundary of Section 28, Block II, Dunback Survey District; thence westerly to and along that southern boundary and north-westerly along the south-western boundaries of that section and Section 27, Block II aforesaid, to the eastern side of McDonald Road; thence generally northerly along the eastern side of that road to
