Should representations be made against the nomination, the Tariff and Development Board will conduct an inquiry and will notify the date on which submissions are required and the form in which they should be lodged. Where such an inquiry results in a decision to include the goods in Schedule A, and where the Australian Government is in agreement, such inclusion will be effected at the earliest practicable date following receipt of the report of the Tariff and Development Board.

If no representations against inclusion in Schedule A have been received by the Board by 14 June 1974, the product will be added to the Schedule at an agreed time subject to the agreement of the Australian Government.
