

ORDER

1. (1) This order may be cited as the Union of Wanganui, Patea-Waitotara and Hunterville Pest Destruction Districts Order 1974.

(2) This order shall come into force on the 1st day of April 1974.

2. The boundaries of the Wanganui Pest Destruction District (which was constituted by Order in Council on the 21st day of March 1956*), the Patea-Waitotara Pest Destruction District (which was constituted by Order in Council on the 21st day of May 1923†), and the Hunterville Pest Destruction District (which was constituted by Order in Council on the 8th day of December 1924‡), are hereby declared united to form one district to be called the Western Pest Destruction District, the boundaries of which shall be those specified in the Schedule hereto.

3. The basis on which the Board for the said District shall first levy its general rate shall be the acreage of the land occupied by the ratepayer.

PURSUANT to the Agricultural Pests Destruction Act 1967, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. (1) This order may be cited as the Union of Manawatu and Rangitoto Pest Destruction Districts Order 1974.

(2) This order shall come into force on the 1st day of April 1974.

2. The boundaries of the Manawatu Pest Destruction District (which was constituted by Order in Council on the 7th day of November 1923*) and the Rangitoto Pest Destruction District (which was constituted by Order in Council on the 8th day of May 1922†), are hereby declared united to form one district to be called the Manawatu Pest Destruction District, the boundaries of which shall be those specified in the Schedule hereto.

3. The basis on which the Board for the said District shall first levy its general rate shall be the acreage of the land occupied by the ratepayer.
