Inorganic chemicals, organic chemicals, organic and inorganic compounds of precious metals, of rare earth metals, of radioactive elements and isotopes, of Tariff Chapters 28 and 29, EXCLUDING the following: Chlorine; sulphur, colloidal; ammonia in aqueous solution; zinc oxide; cuprous oxide, copper sulphate and iron sulphate, other than ferrous sulphate on declaration for use as or with fertilisers; silver nitrate; 2:4:5 trichlorophenolate, trichlorophenol, sodium 2:4:6 trichlorophenolate; formaldehyde and paraformaldehyde; 2:4 trichlorophenoxyacetic acid (2-4D) and 2:4:5 trichlorophenoxyacetic acid (2:4:5-T), and salts and esters thereof; 4 chloro-2 methylphenoxyacetic acid (MCPA) and esters thereof; rennet; sugars, chemically pure; non-metals doped for use in electronics; intermixtures or interalloys of rare earth metals, yttrium and scandium; anhydrous ammonia; sodium hypochlorite; sodium bisulphate and aluminium sulphate; refined naphthalene; simazine, atrazine and propazine.
