Amending a Proclamation Defining the Middle Line of the Onchunga-Manurewa via Mangere Motorway in the Borough of Onchunga

DENIS BLUNDELL, Governor-General A PROCLAMATION

PURSUANT to section 4 of the Public Works Amendment Act 1947, I, Sir Edward Denis Blundell, the Governor-General of New Zealand, hereby amend the Proclamation dated the 4th day of July 1966, published in Gazette, 1966, Vol. 2, p. 1125, and registered as Proclamation No. 167133 North Auckland Land Registry (hereinafter termed "the former Proclamation") defining the middle line of a portion of the Onehunga-Manurewa via Mangere Motorway in the Borough of Onehunga, so that the former Proclamation shall affect not only the land situated within the limits shown coloured red on the plan marked M.O.W. 20129 referred to in the former Proclamation, but also the land described in the Schedule hereto.
