Notice Under Section 4 of the National Savings Act 1940

PURSUANT to section 4 of the National Savings Act 1940, the Minister of Finance hereby prescribes as follows:

(a) The thirty-fifth investment period during which investments by way of deposits in investment accounts may be made shall be the period of 1 year commencing on the 1st day of July 1974, and ending on the 30th day of June 1975;

(b) Subject to the provisions of the said Act, the rate of interest to be paid on such investments made during such investment period shall be 3½ percent per annum;

(c) Subject to the provisions of the said Act, moneys invested as aforesaid, during such investment period, shall be repayable on the 30th day of June 1977, provided that where interest is not withdrawn by the investor in accordance with section 8 (2) of the said Act and is added to and becomes part of the principal moneys of the investor under section 8 (3) of the said Act, the amount of such interest, together with any interest thereon, shall be repayable on the 30th day of June 1976.
