- 4. The roads specified in the Third Schedule hereto are hereby declared to be 40-miles-an-hour speed limit areas for the purposes of regulation 27A of the Traffic Regulations
- 5. The Traffic (Waimairi County) Notice No. 3, 1971, dated the 12th day of November 1971† under regulations 27 and 27A of the Traffic Regulations 1956*, which relates to roads situated within Waimairi County at Brooklands, Spencerville, and Marshland is hereby revoked.

FIRST SCHEDULE

SITUATED within Waimairi County at Marshland, Burwood, and Parkland:
