NOTICE OF INTENTION TO TAKE LAND FOR ROADS

NOTICE is hereby given that the Wellington City Council proposes under the provisions of the above-named Acts and all other Acts powers and authorities enabling it in that behalf to execute a certain public work, namely in connection with street at the junction of Molesworth Street and Hawkestone Street in the City of Wellington and for the purposes of that public work in the land described in the Schedule hereto is required to be taken.
