

Allotment 185, Makarau Parish, shown on D.P. 18176, Lot 2, D.P. 20898, along a right line across Tahekeroa Stream and the Puhoi-Tahekeroa Road to and along the eastern boundaries of Allotment 232, Makarau Parish, Lot 3, D.P. 26487, along a right line across Upper Waiwera Road to and along the eastern boundary of Lot 4, D.P. 26487, along a right line across Upper Waiwera Road to and along the eastern boundary of Lot 5, D.P. 26487, to its easternmost corner, in Block I, Waiwera Survey District; thence easterly along the northern boundaries of Allotment 112, crossing the intervening Upper Waiwera Road, Allotments N. 113, 466, N. 134, crossing the intervening Broady Road, Allotments W. 135, M. 135, N.E. 135, 270, 272, crossing the intervening Waiwera River and Upper Waiwera Road, Allotment 283 along a right line across a stream and Bayers Road, to and along the northern boundaries of Lot 2, D.P. 39203, and Allotment 286, to the northernmost corner of that allotment in Block II, Waiwera Survey District, all the aforesaid allotments being of Waiwera Parish; thence along a right line across Upper Waiwera Road to and along the northern side of that part of the aforesaid road forming the northern boundary of part Allotment 89, Lot 1, D.P. 66462, and Lot 1, D.P. 50186, and continuing along the northern boundary of Allotment 89 and its production to and down the middle of the Waiwera River to a point in line with the northern boundary of Allotment 256, in the aforesaid Block II; thence along a right line to and along that boundary and along the northern boundaries of Allotments 242, 103, 102, 101, and along the north-western boundary of Allotment 104, all the aforesaid allotments being of Waiwera Parish, and along the production of the last-mentioned boundary to and down the middle of the Waiwera River and the middle of the channel of that river south of Te Koroto Block and again down the middle of the Waiwera River to and southerly generally across its mouth to and along the line of mean high water of the Hauraki Gulf to and along the line of mean high water of the left and right banks of the Okura River and the left bank of a tributary of that river to its intersection in Block XVI, Waiwera Survey District, with the north-western boundary of Allotment N.W. 294, Pukeatua Parish; thence north-easterly to and along that north-western boundary and south-easterly along the north-eastern boundaries of Allotment N.W. 294, aforesaid, Allotment S.E. 294, Lot 1, D.P. 32247, Lots, 6, 5, 4, 3, 2, and 1, D.P. 65500 and Lot 4, D.P. 32247, and that boundary produced to the middle of East Coast Road; thence southerly generally along the middle of East Coast Road to and westerly along the middle of Lonely Track Road, to and north-westerly along the middle of State Highway No. 1 to and south-westerly along the middle of State Highway No. 18 to and southerly along the middle of the public road in Block III, Waitemata Survey District, forming the western boundaries of Lots 1 and 2, D.P. 55147, Lots 1 and 2, D.P. 67528, Allotment 207, Paremoparemo Parish, and Lots 1 and 2, D.P. 14439, to and south-westerly along the middle of Ridge Road, to and southerly and south-easterly along the middle of Brookdale Road to its junction with the south-easterly production of the north-eastern boundary of Lot 1, D.P. 67280, in Block VI, Waitemata Survey District; thence south-easterly along that production to the right bank of the Paremoparemo Creek; thence southerly generally along that right bank and continuing generally westerly and southerly along the line of mean high water of the Waitemata Harbour and its creeks to the junction of the left bank of Brighams Creek with the northern boundary of Lot 6, D.P. 53169, in Block IX, Waitemata Survey District; thence westerly along the northern boundaries of Lots 6 and 5, D.P. 53169, and south-westerly along the north-western boundary of Lot 5 and its production to and north-westerly and westerly along the middle of State Highway No. 16, to and southerly generally along the middle of Taupaki and Waitakere Roads to a point in line with the southern boundary of Lot 7, D.P. 41523; thence westerly along a right line to and along that boundary and the generally south-eastern boundaries of Lot 8, D.P. 41523, to its southernmost corner; thence south-westerly along a right line to the north-eastern corner of that part Allotment 27, Waipareira Parish, taken for recreation ground (*Gazette*, 1952, page 1177), and south-easterly along the north-eastern boundary of that part Allotment 27 and its production to the middle of Bethells Road; thence south-westerly along the middle of Bethells Road to and westerly generally along the middle of a public road forming the southern boundaries of Lots 2, 3, 4, and 5, D.P. 31015, to and south-easterly along the middle of a public road forming the north-eastern boundary of Lot 1, D.P. 41021, to a point in line with the north-western boundary of that part of Allotment 5, Waitakere Parish, shown on D.P. 3912 in Block XII, Kumeu Survey District; thence south-westerly along a right line to and along that boundary and south-easterly along the south-western boundary of the said part Allotment 5, and that boundary produced to and westerly

along the middle of Bethells Road to and down the middle of the Waitakere River to a point in line with the north-eastern boundary of Lot 1, D.P. 57924; thence south-easterly along a right line to and along that boundary and its production to and westerly and southerly along the middle of Bethells Road to a point in line with the eastern boundary of Lot 1, D.P. 57923, in Block XI, Kumeu Survey District; thence northerly along the production of that boundary to and down the middle of the Waitakere River to the point of commencement.

SECOND SCHEDULE

AREA TO BE EXCLUDED FROM OTAMATEA COUNTY AND INCLUDED IN RODNEY COUNTY

FIRSTLY: all that area in the North Auckland Land District bounded by a line commencing at the junction of the western side of Pauls Road with the right bank of the Mangawhai Harbour in Block III, Mangawhai Survey District, and proceeding southerly generally along the western side of Pauls Road to a point in line with the middle line of that part of Pauls Road forming the northern boundary of Lot 3, D.P. 24723; thence north-westerly generally along the production of that middle line to and down the middle of the Mangawhai Stream to and north-easterly along the aforesaid right bank to the point of commencement.

Secondly: all that area in the North Auckland Land District bounded by a line commencing at the westernmost corner of Allotment W. 93, Mangawhai Parish, in Block I, Pakiri Survey District, and proceeding northerly along the production of the western boundary of the said Allotment W. 93 to and easterly along the middle line of Cames Road to and southerly along the production of the eastern boundary of Allotment E. 78, Mangawhai Parish, to the southern side of Cames Road; thence westerly along that southern side to the point of commencement.

THIRD SCHEDULE

AREAS TO BE EXCLUDED FROM RODNEY COUNTY AND INCLUDED IN OTAMATEA COUNTY

ALL that area in the North Auckland Land District bounded by a line commencing at the south-eastern corner of Allotment 10, Oruawharo Parish, in Block I, Pakiri Survey District, and proceeding southerly along the production of the eastern boundary of the said Allotment 10 to and westerly along the middle of a public road forming the generally southern boundaries of Allotments 10, 11, 12, Lots 3 and 4, D.P. 42988, and Allotment 18 in Block IV, Otamatea Survey District and continuing south-westerly along the middle of a public road forming the generally south-eastern boundaries of Allotments 229, E. 24, 27, N. 172, S. 172, 173, N. 174, M. 174, S. 174, N. 175, M. 175, S.M. 175, S.W. 175, N.E. 73, W. 73, N.E. 74, and 74A, all the aforesaid allotments being of Oruawharo Parish, to and northerly along the eastern boundary of Otioro and Te Topuni A2A to the easternmost corner of Lot 2, D.P. 30610, in Block VIII, Otamatea Survey District; thence westerly along the southern boundary of Lot 2 aforesaid and the production of the last-mentioned boundary to and north-westerly along the middle of State Highway No. 1 and south-westerly along the middle of Ross Road and the last middle line produced to and north-westerly along the middle of the Newmarket-Opua Railway to and down the middle of the first tributary of the Topuni River shown on S.O. Plan 16358 in Block VII, Otamatea Survey District, to and northerly generally along the lines of mean high water of the right bank of that tributary and the left bank of the Topuni River to and north-easterly up the middle of the Hakaru River to a point in line with the northern site of a public road forming the southern boundary of Allotment 193, Oruawharo Parish, in Block IV, Otamatea Survey District; thence south-easterly generally along a right line to and along that northern side and the generally northern side of the public road forming the southern boundaries of Allotments 31, 30, 29, and 242, and the northern side of the public road shown on S.O. Plan 3683 forming the southern boundaries of Allotments 22, 21, and 18, and continuing along the northern side of the public road forming the southern boundaries of Lots 4 and 3, D.P. 42988, and Allotments 12, 11, and 10, all the aforesaid allotments being of Oruawharo Parish, to the point of commencement. And all that area in the North Auckland Land District bounded by a line commencing at the junction in Block III, Mangawhai Survey District, of the production westerly of the middle of that part of Pauls Road forming the northern boundary of Lot 3, D.P. 24723, with the middle of the Mangawhai Stream and proceeding south-easterly and southerly generally to and along the middle of the said road and the middle of the Tomarata-Mangawhai Road to a point in Block I, Pakiri Survey District, in line with the southern
