

of the Waireia Creek and proceeding southerly and westerly along the eastern and southern boundaries of Paraheke 200N, to its junction with the middle line of a public road which forms the western boundaries of Allotments S. 8 and 9, Wharehine Parish, a piece of Crown land and Allotment 47, Wharehine Parish; thence southerly generally along the middle of that public road to a point in line with the south-eastern boundary of Allotment 47, aforesaid; thence north-easterly along a right line to and along that boundary and continuing along the north-western boundaries of Allotment 84, Tauhoa Parish, to and south-easterly along the north-eastern boundary of Allotment 84, and that boundary produced to and north-easterly up the middle of Whanaki River, to a point in line with the north-eastern boundary of Allotment 83; thence south-easterly along a right line to and along that north-eastern boundary and that boundary produced to and southerly along the middle of Partridges Road and the last middle line produced to its junction with the north-western boundary of Allotment 137; thence north-easterly along that north-western boundary to the first road angle north-east of that junction and south-easterly along a right line crossing Allotment 137, a public road and Allotment 252 to a point on the south-eastern boundary of that Allotment 252, 291.69 metres (1,450 links) distant north-easterly from the northernmost corner of Allotment 134; thence south-westerly along the south-eastern boundary of Allotment 252, to and south-easterly along the north-eastern boundary of Allotment 134 and that boundary produced across State Highway No. 16 to and along the north-eastern boundary of Allotment 131 and continuing along the southern boundaries of Lot 3, D.P. 36063, to and south-easterly along the south-western boundary of Allotment 123 and that boundary produced to and north-easterly along the middle of a public road forming the south-eastern boundaries of Allotments 123 and 127 to and south-easterly along the middle of a public road forming the generally north-eastern boundary of Allotment 164 to a point in line with the northern boundary of Allotment 45, all the aforesaid allotments being of Tauhoa Parish; thence easterly along a right line, to and along that northern boundary to its northernmost corner; thence due south-east to the middle of the Hoteo River and easterly up the middle of that river to a point in line with the northern boundary of Allotment 54, Hoteo Parish, and along a right line to and along that northern boundary and the northern boundary of Allotment 86 to and northerly along the western boundary of Allotment 92 and that boundary produced to the middle of a public road forming the southern and eastern boundaries of Lot 1, D.P. 20679; thence easterly and northerly generally along the middle of that road to a point in line with the northern boundary of Allotment 96; thence easterly along a right line to and along that northern boundary, to and southerly along the eastern boundary of that Allotment 96 to and easterly along the northern boundaries of Allotments 52 and part 51, both allotments shown on D.P. 1285, to and south-easterly along the north-eastern boundary of that part Allotment 51 to and north-easterly along the north-western boundaries of Allotments 48, 47, and 46, to and south-easterly along the north-eastern boundary of that last mentioned allotment, to and easterly along the southern boundary of Allotment 81, all the aforesaid allotments being of Hoteo Parish, to and north-easterly, south-easterly, and south-westerly along the north-western, north-eastern and south-eastern boundaries of Allotment 85, Kourawhero Parish, to and south-easterly along the south-western boundary of Allotment 59, Kourawhero Parish in Block VI, Mahurangi Survey District, and that boundary produced to the middle of a public road which forms the south-eastern boundary of that allotment; thence north-easterly along the middle of that public road to a point in line with the middle line of Phillips Road; thence south-easterly along a right line to and along that middle line and the middle line of the public road forming the south-western boundary of Allotment 93, Mahurangi Parish, and the last-mentioned middle line produced to and south-easterly generally down the middle of the Mahurangi Stream, to and down the middle of the Mahurangi River to a point in line with the south-eastern boundary of Lot 3, D.P. 39497; thence south-westerly along a right line to and along that south-eastern boundary and south-easterly along the north-eastern boundaries of Lots 3 and 2, D.P. 39497, and along a right line across Woodcocks Road to and along the north-eastern boundary of Allotment 64, crossing the intervening State Highway No. 1, to and north-easterly and south-easterly along the north-western and north-eastern boundaries of part Allotment 65, comprised in C.T., Volume 544, folio 300, to and north-easterly along the north-western boundary of part Allotment 66 comprised in C.T., Volume 532, folio 46, to and south-easterly along the north-eastern boundary of Allotment 66 crossing the intervening Thompson Road and continuing along that north-eastern boundary to a point in line

with the south-eastern boundary of part Allotment 71, comprised in C.T., Volume 588, folio 182; thence north-easterly along a right line crossing Lot 1, D.P. 58540, and part Allotment 71, comprised in C.T., Volume 13D, folio 990, to and along that south-eastern boundary, and along a right line across Hepburn Creek Road and part Allotment 71 comprised in C.T., Volume 588, folio 194, to the southernmost corner of Lot 3, D.P. 68790, and along the south-eastern boundary of that Lot 3 and the north-eastern boundary of part Allotment 71 comprised in C.T., Volume 588, folio 194, aforesaid to the right bank of a tributary of the Mahurangi River; thence due north to and down the middle of that tributary to and down the middle of the Mahurangi River and the middle of the Mahurangi Harbour to and up the middle of Dyers Creek to a point in line with the south-western boundary of Allotment 90, Mahurangi Parish in Block XI, Mahurangi Survey District; thence north-westerly along a right line to and along that south-western boundary and the south-western boundary of Allotment 89, crossing the intervening public road to and northerly along the western boundary of Allotment 89 to the south-eastern boundary of Allotment 88; thence south-westerly and north-westerly along the south-eastern and south-western boundaries of that Allotment 88, to and westerly along the southern boundaries of Allotments 206 and 124, to and southerly along the eastern boundary of Allotment 162, along a right line across a public road and again southerly along the eastern boundary of Allotment 161, to and westerly and southerly along the northern and western boundaries of Lot 1, D.P. 37582, to the intersection of the said western boundary with the middle of Dyers Creek; thence south-westerly generally up the middle of that creek to a point in line with the middle line of the public road forming the south-western boundary of Allotment W. 155; thence along a right line to and along the middle of that road and the public road forming the southern boundary of Allotment S. 159 to a point in line with the south-western boundary of Allotment 158A; thence along a right line to and north-westerly along the south-western boundary of that Allotment 158A to the northernmost corner of Allotment S.E. 158, all the aforesaid allotments being of Mahurangi Parish; thence westerly along the northern boundary of that Allotment S.E. 158 crossing the intervening State Highway No. 1 to and northerly along the eastern boundary of Allotment 75, Ahuroa Parish; and that boundary produced to the middle of a public road forming the generally northern boundaries of Allotments 75, 76, and 73, in Block X, Mahurangi Survey District; thence westerly generally along the middle of that road to a point in line with the northern boundary of Allotment 73; thence westerly along a right line to and along that northern boundary and the northern boundaries of Allotments 100 and N. 58, and that last boundary produced to the middle of a public road forming the generally western boundary of Allotment N. 58 aforesaid and Allotment S. 58; thence southerly generally along the middle of that public road to a point in line with the northern boundary of Allotment N. 41; thence westerly along a right line to and along that northern boundary and the northern boundary of Allotment 36, and that last boundary produced to the middle of a public road forming the generally eastern boundaries of Allotments 19, N.W. 18, and S.E. 18; thence southerly along the middle of that road to a point in line with the north-western boundary of Allotment 17 in Block IX, Mahurangi Survey District; thence south-westerly along a right line to and along that north-western boundary and that boundary produced to the middle of the public road forming the generally eastern boundary of Allotment 101; thence northerly generally along the middle of that public road to a point in line with the northern boundary of that Allotment 101; thence along a right line to and along that northern boundary to the eastern side of the Newmarket-Opua Railway; thence westerly along a right line across that railway to and along the generally northern boundaries of Allotment 89, to and northerly along the eastern boundary of Allotment 90 and that boundary produced to and south-westerly along the middle of Warkworth West Coast Road to a point in line with the north-eastern boundary of Allotment 93; thence north-westerly along a right line crossing the Valley Stream to and along that north-eastern boundary to and south-westerly along the north-western boundaries of Allotment 93, aforesaid, and Allotment 94, all the aforesaid allotments being of Ahuroa Parish, to and north-westerly along the generally south-western boundary of Section 3, Block XI, Tauhoa Survey District, to and south-westerly along the south-eastern boundary of Allotment 197, Tauhoa Parish, along a right line across a public road to and along the generally south-eastern boundaries of Allotments 198, 199, 200, and 201, to and north-westerly along the north-eastern boundary of Allotment 204, and that boundary produced to the middle of Glorit-Kaipara Hills Road; thence south-
