

16 and E. 78, Mangawhai Parish, and the last boundary produced to and westerly along the middle of Cames Road to a point in line with the eastern boundary of Allotment 50, Mangawhai Parish; thence southerly along a right line to and along the eastern boundary and westerly along the southern boundary of the said Allotment 50 to and southerly along the eastern boundary of Allotment 10, Oruawharo Parish, and that boundary produced to the middle of a public road; thence westerly along the middle of a public road forming the generally southern boundaries of Allotments 10, 11, 12, Lots 3 and 4, D.P. 42988, and Allotment 18 in Block IV, Otamatea Survey District, and continuing south-westerly along the middle of a public road forming the generally south-eastern boundaries of Allotments 229, E. 24, 27, N. 172, S. 172, 173, N. 174, M. 174, S. 174, N. 175, M. 175, S.M. 175, S.W. 175, N.E. 73, W. 73, N.E. 74, and 74A, all the aforesaid allotments being of Oruawharo Parish, to and northerly along the eastern boundary of Otioro and Te Topuni A2A to the easternmost corner of Lot 2, D.P. 30610, in Block VIII, Otamatea Survey District; thence westerly along the southern boundary of Lot 2 aforesaid and the production of the last-mentioned boundary to and north-westerly along the middle of State Highway No. 1 to and south-westerly along the middle of Ross Road and the last middle line produced to and north-westerly along the middle of the Newmarket-Opua Railway to its intersection with the first tributary of the Topuni River shown on S.O. Plan 16358, in Block VII, Otamatea Survey District; thence westerly down the middle of that tributary to and southerly generally along the left bank of Topuni River, the right and left banks of Te Hana Creek, the left bank of Oruawharo River, the right bank of Wharehine River, the right and left banks of Kaiwakawaka River, the right and left banks of Waireia Creek to the point of commencement and including any adjacent islands, islets, and rocks above the line of mean high water.

#### EIGHTH SCHEDULE

##### WELLSFORD RIDING

ALL that area in the North Auckland Land District bounded by a line commencing at the westernmost corner of Section 2, Block XII, Otamatea Survey District, and proceeding south-easterly along the south-western boundary of that Section 2 and that boundary produced across the public road which forms the generally eastern boundary of Lot 1, D.P. 43537; thence southerly generally along the generally eastern side of that public road to the southern boundary of Section 32, Block XVI, Otamatea Survey District; thence due south to the southern side of Wellsford-Leigh Road crossing part Section 33, Block XVI, Otamatea Survey District, Lot 1, D.P. 57349, and the last-named road; thence south-easterly along the south-western side of Wellsford-Leigh Road and southerly along the western side of a public road which forms the western boundaries of Section 149 and Lots 1 and 2, D.P. 43721, to and westerly along the northern side of the public road which forms the southern boundary of Section 39 to a point in line with the western boundary of Section 42; thence southerly along a right line across that public road, to and along that said western boundary and continuing along the western boundary of Lot 1 and the eastern boundary of Lot 2, D.P. 52153, to and north-westerly and south-westerly along the north-eastern and north-western boundaries of Lot 3, D.P. 26817, to the westernmost corner of that Lot 3; thence south-westerly along a right line to the northernmost corner of Section 62 on the eastern side of State Highway No. 1, crossing Lot 1, D.P. 36280, and part Section 29; thence along a right line to the north-western corner of Lot 3, D.P. 66566, on the eastern side of Prictors Road, crossing State Highway No. 1, parts Section 8, the Newmarket-Opua Railway and the said Lot 3; thence north-westerly along another right line to the junction of the western boundary of Lot 1, D.P. 41191, with the southern side of State Highway No. 16, crossing the aforesaid Prictors Road, part Lot 1, D.P. 33749, part Section 7, all the aforesaid sections being of Block XVI, Otamatea Survey District, and Lot 1, D.P. 41191; thence westerly along the southern side of the said State highway to a point in line with the south-western boundary of Lot 1, D.P. 43213; thence north-westerly along a right line across that State highway, to and along that south-western boundary and continuing along the north-eastern boundary of Lot 2, D.P. 39874, to the northernmost corner of that lot; thence northerly along a right line across Lot 1, D.P. 42587, to a point on the south-western side of Workers Road, in line with the north-western boundary of Lot 1, D.P. 41865; thence north-easterly along a right line across Workers Road, to and along that north-western boundary and the north-western boundary of Lot 2, D.P. 41865, to the southern side of Wellsford Valley Road; thence northerly along a right line across

that road to and north-easterly along the north-western boundaries of Allotments S.W. 119 and M. 119, to and south-easterly along the north-eastern boundary of that Allotment M. 119, to and north-easterly generally along the generally north-western side of a public road forming the generally north-western boundary of Allotment S.W. 118 crossing the intervening State Highway No. 1 to a point in line with the southern boundary of Allotment N.W. 118; thence easterly along a right line across a public road to and along the southern boundaries of Allotments N.W. 118 and N.E. 118, to and southerly and north-easterly along the western and south-eastern boundaries of Allotment 117 crossing the intervening Newmarket-Opua Railway, all the aforesaid allotments being of Oruawharo Parish, to the point of commencement.

#### NINTH SCHEDULE

##### MATAKANA RIDING

ALL that area in the North Auckland Land District bounded by a line commencing in Block XV, Pakiri Survey District, at a point in the middle of the Omaha River in line with the south-eastern boundary of Allotment 30, Matakana Parish, and proceeding south-westerly along a right line to and along that south-eastern boundary, crossing an intervening arm of that river and Warkworth-Leigh Road to and north-westerly and south-westerly along the north-eastern and north-western boundaries of Allotment 85 and the north-western boundary of Allotment 86 to the westernmost corner of that allotment; thence north-westerly along the north-eastern boundary of Allotment 83 to the south-eastern side of a public road; thence north-easterly, north-westerly and south-westerly along the south-eastern, north-eastern, and north-western sides of the said public road, forming the generally north-eastern boundaries of Allotments 48, 47, and 46, to and north-westerly along the north-eastern boundaries of Allotments 105 and 106 in Block XIV, Pakiri Survey District, to and north-easterly along the south-eastern boundary of Allotment 101 to the northernmost corner of that allotment, all the aforesaid allotments being of Matakana Parish; thence south-westerly along the south-eastern boundaries of Allotments 121 and 78, Pakiri Parish, to and northerly generally along the middle of Matakana-Whangaripo Road shown on S.O. Plans 5436D and 5436 to a point in line with the south-eastern boundary of Allotment 74, Pakiri Parish; thence along a right line to and along that boundary and continuing along the generally north-western boundaries of Lots 2 and 1, D.P. 11393, to the westernmost corner of that Lot 1; thence south-easterly along the south-western boundary of that Lot 1, to and south-westerly generally along the middle of a public road crossing Allotment 111, Matakana Parish, to and south-westerly along the north-western boundary of the said Allotment 111, to and north-westerly along the north-eastern boundary of Allotment 82, Pakiri Parish, to and south-westerly along the south-eastern boundary of Allotment 79, Pakiri Parish, and that boundary produced to the middle of a public road which forms part of the generally south-eastern boundaries of Allotment 79, Pakiri Parish; thence south-westerly and north westerly along the middle of that public road to a point in line with the eastern boundary of Allotment 123, Pakiri Parish, in Block XIII, Pakiri Survey District; thence northerly along a right line, to and along that eastern boundary to and north-westerly along the north-eastern boundary of that Allotment 123, to and along the north-eastern boundary of Allotment 109, to and south-westerly and south-easterly along the north-western and south-western boundaries of that Allotment 109 and the last-mentioned boundary produced to and down the middle of the right hand branch of the Waiwhiu Stream to a point in line with the western boundary of that part of Allotment 123 as shown on D.P. 23101; thence southerly along a right line to and along the western boundary of that part Allotment 123 to and westerly along the southern boundary of Allotment 114 and that boundary produced to the middle of a public road which forms the eastern and southern boundaries of Allotment 119; thence southerly and westerly along the middle of that public road to a point in line with the north-eastern boundary of Allotment 68; thence north-westerly along a right line crossing Allotment 119 to and along that north-eastern boundary, to and south-westerly along the north-western boundary of that Allotment 68, to the right bank of the Waiwhiu Stream, all the aforesaid allotments being of Pakiri Parish; thence northerly along the right bank of that stream to a point in line with the north-western boundary of Allotment 39, Hoteo Parish, in Block XIII, Pakiri Survey District; thence south-westerly along a right line across the Waiwhiu Stream to and along the north-western boundary and that boundary produced to and along the middle of a public road which forms the eastern and south-eastern boundaries of Allotment
