

thence north-westerly along a right line to that northernmost corner being on the right bank of the Hotoe River and westerly along part of the northern boundary of that Allotment 45 and that boundary produced to the middle of a public road forming the generally north-eastern boundary of Allotment 164; thence north-westerly along the middle of that public road to and south-westerly along the middle of the public road forming the south-eastern boundaries of Allotments 127 and 123, to a point in line with the south-western boundary of that Allotment 123; thence north-westerly along a right line to and along that south-western boundary, to and north-easterly along the north-western boundaries of Allotments 123, 127, and 120A to and north-westerly along the south-western boundaries of Lots 2 and 1, D.P. 55393, and that last boundary produced across part Allotments 130 and 130A, to the south-eastern boundary of Allotment 77; thence south-westerly, north-westerly, and north-easterly generally along the south-eastern, south-western, and generally north-western boundaries of Allotment 77 and that last boundary produced across a public road forming the north-eastern boundary of Allotment 75, all the aforesaid allotments being of Tauhoa Parish, to and north-westerly along the north-eastern side of that road and that roadside produced to its junction with the middle of State Highway No. 16; thence south-easterly along the middle of the public road forming the north-eastern boundary of Section 2A, Block XVI, Otamatea Survey District, to and easterly and north-easterly along the middle of a public road forming the generally northern boundaries of Lots 1 and 2, D.P. 15534, and sections 11, 12, 13, and 21, crossing the intervening Pricors Road and Newmarket-Opuia Railway to and northerly along the middle of State Highway No. 1 to its intersection with a right line between the north-western corner of Lot 3, D.P. 66566, on the eastern side of Pricors Road and the northernmost corner of Section 62, Block XVI, Otamatea Survey District, on the eastern side of State Highway No. 1; thence north-easterly generally along that line to that northernmost corner and along another right line to the westernmost corner of Lot 3, D.P. 26817, crossing part Section 29 and Lot 1, D.P. 36280; thence north-easterly and south-easterly along the north-western and north-eastern boundaries of Lot 3, aforesaid, to and north-easterly along the south-eastern boundary of Lot 2, D.P. 52153, and the north-western boundary of Lot 1, D.P. 52153, and continuing along the north-western boundary of Section 42, Block XVI, aforesaid, and that last boundary produced across a public road forming the generally southern boundaries of Section 39, Block XVI, aforesaid; thence easterly along the northern side of that public road to and northerly along the western side of the public road forming the generally western boundaries of Lots 2 and 1, D.P. 43721, and Section 149, Block XVI, aforesaid, to and north-westerly along the south-western side of Wellsford-Leigh Road to a point due south of the south-western corner of Section 32, Block XVI, aforesaid; thence due north across Wellsford-Leigh Road, part Section 33, Block XVI, aforesaid, and Lot 1, D.P. 57349, to that south-western corner on the eastern side of the public road forming the generally eastern boundaries of Lot 1, D.P. 43537; thence northerly along the eastern side of that road to a point in line with the south-western boundary of Section 2, Block XII, Otamatea Survey District; thence north-westerly along a right line across that public road to and along the south-western boundary of Section 2, aforesaid, to and north-easterly along the north-western boundary of that Section 2 and that boundary produced across the intervening public road, to and north-easterly along the north-western boundaries of that Section 2, to a point in line with the southernmost boundary of Section 1, Block XII, aforesaid; thence westerly along a right line across the last-mentioned public road, to and along the generally southern boundaries of Section 1 aforesaid, to and northerly and easterly along the western and northern boundaries of that Section 1, and continuing along the northern side of a public road which forms the northern boundaries of Section 27, Block VIII, Pakiri Survey District, crossing an intervening public road and continuing easterly along the southern boundary of Allotment 104, Oruawharo Parish, to and north-easterly along the south-eastern boundary of Allotment 104, aforesaid, and the south-eastern boundaries of Allotment E. 93 and Allotment S.E. 92, along a right line across a public road to and north-easterly along the south-eastern boundaries of Allotments 88, S.W. 87, N. 87, 85, and 67, all the aforesaid allotments being of Oruawharo Parish, to the north-eastern corner of the last-mentioned allotment; thence south-easterly along a right line perpendicular to the last-mentioned boundary across a public road forming the western boundary of Allotment 100, Arai Parish, to and northerly along that western boundary and easterly and south-easterly along the northern and north-eastern boundaries of that Allotment 100, and

south-easterly along the north-eastern boundary of Lot 6, D.P. 31093, along a right line across a public road to and along the south-western boundaries of Allotment 97, to its southernmost corner and along the end of a public road and the north-eastern boundary of Allotment 105, all aforesaid allotments being of Arai Parish, and along a right line across Pools Road to the northernmost corner of Section 17S, Waiteitei Settlement, and along its north-eastern boundary to its easternmost corner; thence north-easterly along the north-western boundary of Section 18S, Waiteitei Settlement, and continuing along the south-eastern boundaries of Allotments 64 and 65, Arai Parish, Allotment 66, shown on D.P. 8508, Allotments S. 67, N. 67, and 68, crossing the intervening school road, Lots 2 and 1, D.P. 35587, across the end of a public road and the south-eastern boundaries of Allotments 5 and 4, across the end of another public road and along the south-eastern boundaries of Allotments S.W. 3, M. 3, N.E. 3, and 2, crossing the intervening public road and along the south-eastern boundary of Allotment 1, and continuing along the south-eastern boundary of Lot 1, D.P. 56218, and that last-mentioned boundary produced across Allotment 114, all the aforesaid allotments being of Arai Parish to the sea coast of the South Pacific Ocean, in Block III, Pakiri Survey District; thence south-easterly along that sea coast to the point of commencement and including any adjacent islands, islets, and rocks above the line of mean high water.

OMAHA RIDING

ALL that area in the North Auckland Land District bounded by a line commencing in Block VII, Pakiri Survey District, at the northernmost corner of Pakiri G Block on the sea coast of the South Pacific Ocean and Hauraki Gulf and proceeding southerly generally along that sea coast to and westerly generally up the middle of the Whangateau Harbour and the Omaha River to a point in line with the north-western boundary of Allotment 30A, Matakana Parish, in Block XV, Pakiri Survey District; thence south-westerly along a right line to and along that north-western boundary along a right line across an arm of that river, to and along the north-western boundary of Allotment 34, crossing the intervening Warkworth-Leigh Road to and north-westerly along the north-eastern boundary of Allotment 85, to and south-westerly along the north-western boundaries of Allotments 85 and 86, to the westernmost corner of that Allotment 86; thence north-westerly along the north-eastern boundary of Allotment 83 to and easterly along the southern side of a public road, and north-easterly, north-westerly, and south-westerly along the south-eastern, north-eastern, and north-western sides of that road, to and north-westerly along the north-eastern boundaries of Allotments 105 and 106 in Block XIV, Pakiri Survey District, to and north-easterly along the south-eastern boundary of Allotment 101 to its northernmost corner, all the aforesaid allotments being of Matakana Parish; thence north-easterly along the south-eastern boundary of Allotment 121, Pakiri Parish, to and westerly along the northern boundary of that Allotment 121, to and along the southern and western sides of a public road, which forms the southern and western boundaries of Allotment 94, to the north-easternmost corner of Allotment 117; thence northerly along a right line across a public road to and along the eastern boundaries of Allotment 101 to and generally westerly along the generally northern boundaries of that allotment, to a point in line with the western boundary of Allotment 55; thence northerly along a right line across Allotment 126 (closed road) to and along the western boundary of Allotment 55 to its north-western corner, all the aforesaid allotments being of Pakiri Parish; thence north-westerly along a right line across Lot 8, D.P. 16636, and Pakiri K4 Block to the southernmost corner of Section 14, Block X, Pakiri Survey District, and north-easterly along the south-eastern boundaries of Sections 14, 15, 16, and 17, Block X, Pakiri Survey District, to and northerly along the eastern boundaries of that Section 17, to and north-easterly along the north-western boundaries of Pakiri F and G Blocks crossing the intervening Rahuikiri Road to the point of commencement and including Goat Island, Motupanetiki Island, and Horseshoe Island, and any other adjacent islands, islets, and rocks above the line of mean high water.
