Thirdly, that the boundaries of the said six ridings be as shown on a series of six maps endorsed "Waikouaiti County Riding Boundaries 1974" No. 1, No. 2, No. 3, No. 4, No. 5, and No. 6.

Fourthly, that the alteration hereby made take effect on the day of the general election of councillors to be held during the month of October 1974.

I further certify that the following Schedules set out the descriptions, supplied by the Chief Surveyor, of the six riding boundaries referred to in the foregoing Special Order, and shown on the maps endorsed "Waikouaiti County Riding Boundaries 1974" No. 1, No. 2, No. 3, No. 4, No. 5, and No. 6.
