

thence north-easterly along a right line to and along the said south-eastern boundary to the south-western boundary of Allotment W15 and north-westerly, north-easterly and south-easterly along the south-western, north-western and north-eastern boundaries of Allotment W15, to the north-western boundary of Allotment 17, as shown on D.P. 3191 and north-easterly along the north-western boundary of Allotment 17 and north-westerly, north-easterly and south-easterly along the south-western, north-western and north-eastern boundaries of Allotment 109 and the last-mentioned boundary produced across Huia Stream to the western boundary of Allotment 8A as shown on D.P. 3191; thence northerly and easterly along the western and northern boundaries of the said Allotment 8A to its northernmost corner; thence north-easterly along a right line across Allotment 112 to the southernmost corner of Allotment 30, all the aforesaid allotments being of Karangahape Parish; thence north-easterly along the south-eastern boundary of Allotment 30 aforesaid and the north-western boundary of Lot 2, D.P. 9782 and the last boundary produced to the middle of Nihotupu Stream; thence easterly generally along the middle of that stream to a point in line with the western boundary of Allotment 38, Waikomiti Parish, as shown on S.O. 27C; thence northerly, easterly, and southerly along the western, northern, and eastern boundaries of the said Allotment 38, crossing and recrossing the intervening public roads to the northern boundary of Allotment 37; thence easterly and southerly along the northern and eastern boundaries of Allotment 37, to the northern boundary of Allotment 55; thence easterly along that northern boundary and the northern boundary of Allotment 56 crossing the intervening area of 5.0965 hectares (12 acres 2 roods 15 perches) being stopped road shown on S.O. plan 40327, to and northerly and easterly along the western and northern boundaries of Allotment 31 to the southernmost corner of Lot 1, D.P. 50278; thence northerly along the western boundaries of the said Lot 1 and Allotment 30 crossing the intervening public road to the southern boundary of Lot 13, D.P. 37552; thence easterly and northerly along the southern and eastern boundaries of Lot 13 aforesaid and easterly generally along the generally southern boundaries of Lots 1, 2 and 3, D.P. 49446, Lots 18-27 inclusive D.P. 37552 and the last-mentioned boundary produced to the middle of Shaw Road; thence north-westerly along the middle of Shaw Road to and north-easterly along the middle of Waitakere Scenic Drive to a point in line with the western boundary of Lot 1, D.P. 62772; thence southerly along a right line to and along the western boundaries of Lot 1, D.P. 62772 and Lot 2, D.P. 63764 and Lots 4 and 5, D.P. 62772, to and easterly along the southern boundary of Lot 5 aforesaid, along a right line across Allotment 17 and again easterly along the northern boundary of Lot 1, D.P. 35700, to the northernmost corner of that Lot 1; thence northerly along the eastern boundaries of Allotment 17 and Lot 4, D.P. 42411, and that boundary produced to and north-easterly along the middle of Waitakere Scenic Drive to a point in line with the eastern boundary of Lot 1, D.P. 7428; thence northerly along a right line to and along that eastern boundary to and easterly along the southern boundary of Lot 1, D.P. 28402, to and northerly along the western boundaries of Lots 24, 23, 22, 21, 20, 19, 18, 17, and 16, D.P. 43701, to the north-western corner of that Lot 16; thence northerly along a right line across part Lot 1, D.P. 28402, to the south-western corner of Lot 15, D.P. 43701, and along the western boundaries of that Lot 15 and Lots 14, 13, 12, 11, 10, 9, 8, 7, 6, 5, and 4, D.P. 43701 and north-westerly along the south-western boundaries of Lots 2 and 1, D.P. 43701, to the westernmost corner of that Lot 1; thence easterly along the northern boundary of that Lot 1 and that boundary produced to and southerly generally along the middle of Glengarry Road and along the middle of Phillip Avenue and Shetland Street to a point in line with the northern boundary of Lot 1, D.P. 44191; thence easterly generally along a right line to and along that northern boundary and the northern boundaries of Lot 1, D.P. 41904; and Lot 3, D.P. 54638 to the southernmost corner of Lot 35, D.P. 63965; thence north-easterly generally along the generally north-western boundaries of Lot 3, D.P. 54638, Lot 4, D.P. 43899, Lots 113, 114 and 116, D.P. 50279, along a right line across Matama Road to and along the north-western boundary of Lot 103, D.P. 50279, the north-eastern boundaries of Lots 13 and 12, D.P. 39625, to and along the north-western boundaries of Lots 72, 71, and 70, D.P. 8736, to and along the north-western boundaries of Lots 6, 5, and 1, D.P. 20510, along a right line across Withers Road to and along the southern boundaries of Lot 2, D.P. 35583, Lots 4, 1 and 65, D.P. 59664, crossing the intervening Captain Scott Road, Lots 64, 62, 59, 56, and 54, D.P. 60522, Lots 3, 4 and 5, D.P. 62523, Lot 7,

D.P. 42316, to and northerly generally along the eastern boundaries of that Lot 7 and Lots 6, 5 and 4, D.P. 42316, to the north-eastern corner of that Lot 4; thence north-easterly along a right line across Pleasant Road to and along the north-western boundaries of Lots 1 to 8 inclusive, D.P. 33070, Lots 1 to 12 inclusive, D.P. 38865, Lots 1 to 5 inclusive, D.P. 40846, Lot 1, D.P. 45863, and Lot 2, D.P. 48735, to its northernmost corner; thence south-easterly generally along the north-eastern boundary of Lot 2, D.P. 48735, and continuing along the north-eastern boundary of Allotment 138, Waikomiti Parish, along a right line across Titirangi Road to and along the north-eastern boundaries of Lot 9, D.P. 23375 (Plantation Reserve), Lots 5 and 7, D.P. 39449, along a right line across West Lynn Road to and along the north-eastern boundaries of Lot 1, D.P. 10388, and Lot 3, D.P. 64801, and that boundary produced to and along the north-eastern boundary of Lot 6, D.P. 64801, to its south-eastern end; thence north-easterly along the south-eastern boundaries of Lots 6 and 7, D.P. 40481, to and south-easterly along the south-western side of Parker Avenue to a point in line with the middle of Hutchinson Avenue; thence north-easterly along a right line across Parker Avenue to and along that middle line, to and southerly along the middle of Arahoe Road to a point in line with the south-eastern boundary of Lot 15, D.P. 10738; thence along a right line to the westernmost corner of Lot 1, D.P. 46392, and along the western boundary of that lot and continuing along the eastern boundaries of Allotments 558, 648, 649, 652, and 557, Waikomiti Parish, and the last-mentioned boundary produced to and easterly along the middle of Golf Road, to and southerly along the middle of Portage Road to its intersection with the left bank of the Avondale Stream; thence north-easterly generally along the said left bank to its intersection in Block III, Titirangi Survey District, with the northern boundary of part Allotment 363, Waikomiti Parish, taken for New Lynn Domain by *New Zealand Gazette*, 1938, p. 1552; thence easterly and southerly along the northern and eastern boundaries of the said part Allotment 363 to and westerly along the northern side of Heaphy Street to a point in line with the western boundary of Lot 1, D.P. 52190; thence southerly along a right line across Heaphy Street to and along the western boundary of Lot 1, D.P. 52190, and continuing along the generally eastern boundary and south-westerly along the south-eastern boundary of the said part Allotment 363 to its southernmost corner; thence southerly along the eastern side of Portage Road to its junction with the southern side of Connaught Street; thence easterly along that southern side to the eastern boundary of Allotment 381, Waikomiti Parish; thence southerly and westerly along the eastern and southern boundaries of Allotment 381 aforesaid to and southerly along the eastern boundary of Allotment 384, Waikomiti Parish, and that boundary produced across Taunton Terrace to the line of mean high water of the Manukau Harbour; thence westerly generally along the said line of mean high water to and northerly along the line of mean high water of the Tasman Sea, to the point of commencement and including Paratutai Island, Ninepin Rock, and Cutters Rock.

ALL that area in the North Auckland Land District bounded by a line commencing in Block I, Waitakere Survey District, at the intersection of the line of mean high water of the Tasman Sea and the middle of the Waitakere River and proceeding north-easterly generally up the middle of the Waitakere River to its junction with the production northerly of the eastern boundary of Lot 1, D.P. 57923, in Block XI, Kumeu Survey District; thence southerly along that production to and easterly along the middle of Bethells Road, to a point in line with the eastern boundary of Lot 1, D.P. 57924, in Block XII, Kumeu Survey District; thence northerly along a right line to and along that eastern boundary and that boundary produced to the middle of the Waitakere River; thence easterly up the middle of the Waitakere River to its intersection with the middle of Bethells Road; thence north-easterly along the middle of Bethells Road to a point in line with the south-western boundary of part Allotment 5, Waitakere Parish, as shown on D.P. 3912; thence north-westerly to and along that south-western boundary and north-easterly along the north-western boundary of the said part Allotment 5, and that boundary produced to the middle of a public road forming the north-eastern boundary of Lot 1, D.P. 41021; thence north-westerly along the middle of that road, to and easterly along the middle of a public road forming the southern boundaries of the land shown on
