SITUATED within Waitemata County at Whangaparaoa:

All that area of Whangaparaoa Peninsula, with the exception of Whangaparaoa Road, bounded by a line commencing at a point on the north-eastern side of Whangaparaoa Road at its intersection with Viponds Road; thence north-easterly by a right line to a point on the northern shore of the said peninsula; thence easterly generally along the said shoreline to a point due west of the western end of Roberts Road; thence due east by a right line to the junction of Whangaparaoa Road and Roberts Road; thence south-easterly generally by a right line to a point on the shoreline of Whangaparaoa Peninsula at the eastern end of Matakatia Parade; thence westerly generally along the said shoreline to a point due south of the intersection of D'Oyly Drive with Whangaparaoa Road; thence due north by a right line to a point on the south-western side of Whangaparaoa Road opposite the north-western side of D'Oyly Drive; thence across Whangaparaoa Road at right angles from its south-western side of its north-eastern side; thence north-westerly generally along the said side of the said road to its intersection with Viponds Road; thence by a right line across Viponds Road to the commencing point.

Whangaparaoa Road: from Stanmore Bay Road to Roberts Road and from a point 720 metres measured westerly generally along Whangaparaoa Road from Matuketekete Avenue to a point 200 metres measured easterly generally along Whangaparaoa Road from Everard Avenue.

SECOND SCHEDULE

SITUATED in Rodney County, at Matakana:

Warkworth-Leigh Road: from a point 600 metres measured south-westerly generally along the said road from the Whangaripo-Matakana Road to a point 200 metres measured north-easterly generally along the Warkworth-Leigh Road from the Whangaripo-Matakana Road.

Whangaripo-Matakana Road: from the Warkworth-Leigh Road to a point 480 metres measured north-westerly generally along the Whangaripo-Matakana Road from the Warkworth-Leigh Road.

At Orewa:

No. 1 State Highway (Awanui-Bluff): from a point 160 metres measured north-easterly generally along the said State highway from Moffats Road to a point 32 metres measured south-westerly generally along the said State highway from Moffats Road.

At Whangaparaoa:

Whangaparaoa Road: from Stanmore Bay Road to a point 160 metres measured north-westerly generally along Whangaparaoa Road from D'Oyly Drive.

Adjacent to Helensville Borough:

Hand Road: from Maungakura Road to Garfield Street.
 Maungakura Road: from Hand Road to the southern boundary of Helensville Borough.

St James Avenue: from Maungakura Road to Hand Road.

At Huapai and Kumeu:

No. 16 State Highway (Auckland-Wellsford): from Station Road, Huapai, to the bridge at a point 200 metres measured south-easterly generally along the said State highway from the entrance to Kumeu Railway Station.

Access Road: from the No. 16 State Highway (Auckland-Wellsford) to a point 480 metres measured south-westerly generally along the said road from the said highway.

Matua Road: from the No. 16 State Highway (Auckland-Wellsford) to Oraha Road.

Oraha Road: from the No. 16 State Highway (Auckland-Wellsford) to a point 160 metres measured north-easterly generally along the said road from Matua Road.

Tapu Road: from the No. 16 State Highway (Auckland-Wellsford) to a point 400 metres measured northerly generally along the said road from the said highway.

At Kaukapakapa:

No. 16 State Highway (Auckland-Wellsford): from a point 160 metres measured northerly generally along the said highway from North Crescent to a point 560 metres measured south-easterly generally along the said highway from the said crescent.

At Riverhead:

All that area bounded by a line commencing at a point on the northern side of the No. 18 State Highway (Brighams Creek - Albany) at the western end of the bridge across the Rangitopuni Creek; thence across the said State highway at right angles to its northern side, to its southern side; thence southerly generally along the western bank of the said creek to a point opposite the southern side of the Kaipara Portage Road; thence westerly generally along the said roadside to the eastern side of the said State highway; thence across the said State highway, at right angles to its eastern side, to its western side; thence across Riverhead Road, at right angles to its southern side, to its northern side; thence northerly generally along the western side of the said State highway to the junction of the said State highway with Alice Street; thence northerly generally along the western side of Alice Street to the northern side of Queen Street; thence easterly generally along Queen Street to the western side of the said State highway; thence northerly generally along the western side of the said State highway to its junction with Great North Road; thence northerly generally along the western side of Great North Road to the end of the said road; thence easterly generally across Great North Road from its western side to its eastern side; thence south-easterly generally by a right line to the commencing point.

THIRD SCHEDULE

SITUATED within Waitemata County:

At Orewa:

No. 1 State Highway (Awanui-Bluff): from a point 160 metres measured north-easterly generally along the said State highway from Moffats Road to a point 60 metres measured southerly generally along the said State highway from Beach Road; and from a point 40 metres measured north-westerly generally along the said State highway from Florence Avenue to a point 200 metres measured north-westerly generally along the said State highway from Puriri Street.
