The Traffic (Takapuna City) Notice No. 1, 1974

PURSUANT to the Transport Act 1962 the Minister of Transport hereby gives the following notice.

NOTICE

1. This notice may be cited as the Traffic (Takapuna City) Notice No. 1, 1974, and shall come into force on the date of dissolution by Order in Council of the Waitemata County and the creation of Waitemata City.

2. The roads specified in the First Schedule hereto are hereby excluded from the limitation as to speed imposed by section 52 of the Transport Act 1962.

3. The roads specified in the Second Schedule hereto are hereby declared to be 40-miles-an-hour speed limit areas for the purposes of regulation 27A of the Traffic Regulations 1956*.

4. The Traffic (Takapuna City) Notice No. 1, 1969, dated the 19th day of November 1969† and the Traffic (Waitemata County) Notice No. 1, 1973, dated the 3rd day of April 1973‡, and the Traffic (Waitemata County) Notice No. 5, 1973, dated the 1st day of November 1973§, under section 52 of the Transport Act 1962, and regulation 27A of the Traffic Regulations 1956*, which relate to roads situated within Takapuna City, Waitemata County at Albany and Glenfield Ridings and Waitemata County at Albany respectively, are hereby revoked.

FIRST SCHEDULE

SITUATED within Takapuna City:

No. 1 State Highway (Awanui-Bluff): from Hillside Road Junction with the said State highway to the boundary with Rodney County.

Greenhithe Road: from a point 160 metres measured easterly along the said road from Churchhouse Road to the No. 1 State Highway (Awanui-Bluff).

View Road: from a point 240 metres measured southerly generally along View Road from Craig Road to Greenhithe Road (at its northern end).

SECOND SCHEDULE

No. 1 State Highway (Awanui-Bluff): from Hillside Road to Glendhu Road and from a point 120 metres measured north-easterly generally along the said State highway from Otcha Stream Bridge to the northern end of Bush Road.

Target Road: from Sunset Road to a point 480 metres measured north generally along Target Road from Sunnynode Road West and from a point measured south-easterly generally along Target Road from Ellice Road to the said State highway.
