## THE MARLBOROUGH AGRICULTURAL AND PASTORAL ASSOCIATION BILL

## NOTICE OF PRIVATE BILL

IN the matter of the standing orders of the House of Representatives relating to Private Bills and in the matter of a Private Bill intituled "An Act to enable the Marlborough Agricultural and Pastoral Association to dispose of certain land in the Borough of Blenheim and to enter into arrangements with the Blenheim Borough Council for the use of the land":

NOTICE is hereby given that the Marlborough Agricultural and Pastoral Association, duly incorporated under the Agricultural and Pastoral Societies Act 1908, intends to apply for leave to bring into the House of Representatives at the present session a Private Bill intituled as above.
