NOTICE is hereby given that the Taumarunui County Council proposes under the provisions of the above-mentioned Acts to take the land described in the Schedule hereto, such land to be used to provide a rubbish tip to serve the Omori County Town. And notice is hereby further given that the plans of the lands required to be taken are deposited at the public office of the said Council situated in Manuauete Street, Taumarunui, and are open for inspection without fee by all persons during ordinary business hours. All persons affected by the taking of the said lands if they have any objections (which are not objections as to the amount of payment of compensation) which they may wish to make to the taking of the said lands, must state their objections in writing and send the same within 40 days from the first publication of this notice to the Town and Country Planning Appeal Board at Wellington; and that, if any objection is made in accordance with this notice, a public hearing of the objection will be held, unless the objector otherwise requires, and each objector will be advised of the time and place of the hearing.
