The essence of all such verses is that it should be spoken or sung as the editors note "rowdily, rhythmically and *con multo gusto*". There is no question of any literary or other merit or importance in this collection.

Many of the items are indecent and there is no redeeming feature in the collection as a whole which would render it acceptable.

The Tribunal classifies this book as indecent.

# Poisons Regulations 1964—Approval of Alternative Form of Record
