PURSUANT to section 421 of the Maori Affairs Act 1953, I, Sir Edward Denis Blundell, the Governor-General of New Zealand, hereby (a) declare the land described in the First Schedule hereto to be street, and to be vested in the Mayor, Councillors, and Citizens of the City of Tauranga, and (b) further declare the land described in the Second Schedule hereto to be road, and to be vested in the Chairman, Councillors, and Inhabitants of the County of Tauranga, the said land, described in the First and Second Schedules hereto being comprised in a roadway laid out by the Maori Land Court by orders made on the 8th day of May 1916 and the 21st day of October 1969 21st day of October 1969.
