1. Title and commencement—(1) This order may be cited as the Mangawhero and Mangawheroiti Streams Pollution Control Order 1975

(2) This order shall come into force on the day after the date of its publication in the Gazette.

2. Control of the Mangawhero and Mangawheroiti Streams All those portions of the Mangawhero and Mangawheroiti Streams and their tributaries which are within the boundaries of the land described in the Schedule hereto are hereby declared to be under the control of the Waimate West County Council for the purpose of preventing the pollution of those portions of those streams and their tributaries.

SCHEDULE

ALL that area in the Taranaki Land District situated in the Counties of Eltham and Stratford, being that portion of the watershed of the Mangawheroiti Stream and its tributaries from the boundary of the Egmont National Park to the existing intake of the supply of water to the County of Waimate West.

All that area situated in the County of Eltham, being that portion of the watershed of the Mangawhero Stream and its tributaries from the boundary of the Egmont National Park to the Gabion Weir.
