thence across Wallace Road at right angles from its eastern side to its western side; thence westerly generally by a right line across the southern end of Wellesley Road to a point on the bank of the oxidation pond; thence northerly and westerly generaliy along the bank of the oxidation pond and northerly and easterly generally along the shore of the Manukau Harbour to a point opposite the end of Miro Rodad; thence due east by a right line to the western boundary of Otahuhu Borough; thence southerly generally along that boundary to the commencing point.

No. 20 State Highway (Onehunga-Redoubt Road) : all that section now formed by the Mangere Bridge.

## At Otara:
