A PROCLAMATION

PURSUANT to section 19 of the Urban Renewal and Housing Improvement Act 1945, I, Sir Edward Denis Blundell, the Governor-General of New Zealand, hereby proclaim the land defined in the Schedule hereto to be a reclamation area under Part II of the said Act; and I also declare that this Proclamation shall take effect on and after the 13th day of February 1975.

SCHEDULE

WELLINGTON LAND DISTRICT

ALL of those pieces of land situated in the City of Wellington bounded by Aro and Willis Streets, Ohiro and Brooklyn Roads, and containing together 1 acre 3 roods 2.39 perches, be the same a little more or less, being:
