## ORDER IN COUNCIL

PURSUANT to the Trustee Savings Banks Act 1948, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

## ORDER

**1. Title and commencement**—(1) This order may be cited as the Wellington Savings Bank (Change of Name) Order 1975.

(2) This order shall come into force on the date of its publication in the *Gazette*.

**2. Change of name**—(1) The Wellington District Savings Bank (which was constituted by the Wellington Savings Bank Order 1964\*) shall hereinafter be called the Wellington Savings Bank.

(2) The savings bank referred to in subclause (1) of this clause is hereby declared to be the same savings bank as existed immediately before the commencement of this order under the name then applicable.

(3) The provisions of subsections (3), (4), and (5) of section 2 of the Trustee Savings Banks Amendment Act 1964 shall, with the necessary modifications, apply with respect to the savings bank referred to in subclause (1) of this clause as if it were a savings bank referred to in those subsections.

**3. Revocations**—The Trustee Savings Banks (Changes of Names) Order 1964† and the Trustee Savings Banks (Changes of Names) Order 1964, Amendment No. 2‡ are hereby consequentially revoked.
