

Declaring Lands to be Infected Areas Under Potato Cyst Nematode Regulations 1974 (No. 1056 Ag. 61422)

PURSUANT to regulation 3 (1) of the Potato Cyst Nematode Regulations 1974, notice is hereby given that the following lands are declared to be infected areas:

- (a) The land on which potato cyst nematode has been found—an area of 8 acres 3 roods 6 perches, or thereabouts, situated north and of adjoining Mairehau Road, Christchurch, in Blocks VII and VIII of the Christchurch Survey District, being part of Rural Section 1778 and being more particularly described in conveyance registered No. 121712 (195/221), C.T. 392/99 (Canterbury Registry).
