3. The roads specified in the Second Schedule hereto are hereby declared to be 40-miles-an-hour speed limit areas for the purposes of regulation 27A of the Traffic Regula-tions 1956*.

4. The road specified in the Third Schedule hereto is hereby excluded from the limitation as to speed imposed by section 52of the Transport Act 1962.

SITUATED within the Bay of Islands County at Russell:
