

Reservation of Land and Appointment of the Minister of Internal Affairs to Control and Manage

PURSUANT to the Land Act 1948, the Minister of Lands hereby sets apart the land described in the Schedule hereto as a reserve for wildlife management purposes and further, pursuant to the Reserves and Domains Act 1953, appoints the Minister of Internal Affairs to control and manage the said reserve, subject to the provisions of the last mentioned Act, and the Wildlife Act 1953, as a reserve for wildlife management purposes.

Revocation of the Reservation Over a Reserve Specifying the Manner of Disposal and How Proceeds of Sale Shall be Utilised
