## NOTICE

1. This notice may be cited as the Traffic (Golden Bay County) Notice No. 1, 1975.

2. The roads specified in the First Schedule hereto are hereby declared to be closely populated localities for the purpose of section 52 of the Transport Act 1962.

3. The road specified in the Second Schedule hereto is hereby declared to be a limited speed zone for the purposes of regulation 27 of the Traffic Regulations 1956\*.

4. The Traffic (Golden Bay County) Notice No. 3, 1958, dated the 8th day of January 1958†, under section 52 of the Transport Act 1962, and regulation 27 of the Traffic Regulations 1956\*, which relates to roads within the Golden Bay County at Collingwood is hereby revoked.
