##### SPECIAL ORDER

THE Auckland Regional Authority in exercise of the powers vested in it by the Auckland Regional Authority Act 1963, section 42, and in pursuance of the authority conferred upon it under the Local Authorities Loans Act 1956, and in exercise of all other powers enabling it on that behalf doth hereby resolve by special resolution intended to operate as a special order to borrow the sum of three hundred and seventy-eight thousand dollars (\$378,000) as a special loan to be known as Forestry Encouragement Loan No. 3, 1975, \$378,000, for the purposes of establishing forestry plantations totalling 3,700 acres and reimbursing the general account expenditure previously incurred for this purpose.

The foregoing special order was passed at an ordinary meeting of the Auckland Regional Authority held on 18 August 1975 and confirmed at an ordinary meeting of the said Authority held on 15 September 1975, having meantime been advertised in the *Auckland Star*, on 23 August and on 6 September 1975.
