#### A PROCLAMATION

PURSUANT to section 19 of the Urban Renewal and Housing Improvement Act 1945, I, Sir Edward Denis Blundell, the Governor-General of New Zealand, hereby proclaim the land, defined in the Schedule hereto, to be a reclamation area under Part II of the said Act; and I also declare that this Proclamation shall take effect on and after the 6th day of October 1975.

#### SCHEDULE

##### AUCKLAND LAND DISTRICT

ALL of those parcels of land, situated in the City of Auckland, bounded by Schofield and Dryden Streets and Williamson Avenue containing—Firstly: two thousand two hundred and seventy-seven (2277) square metres, more or less, being Lots 1, 2, 3, 4, and 5, Section 37, Deposited Plan 329, and being part Allotment 39, Section 8, Suburbs of Auckland, and

being all the land contained in certificate of title 1967/26, North Auckland Registry; and secondly: one thousand four hundred and nineteen decimal 3 (1419.3) square metres, more or less, being Lots 7, 8, and 9 of Block 37 on Deposited Plan 329, and being part of Allotment 39, Section 8, Suburbs of Auckland, and being all the land contained in certificate of title 5D/28, North Auckland Registry; as the same are more particularly delineated on the plan marked 180/17 deposited in the office of the Minister of Housing at Wellington, and thereon edged red.
