A PROCLAMATION

PURSUANT to the Public Works Act 1928, I, Sir Edward Denis Blundell, the Governor-General of New Zealand, hereby proclaim and declare that the land described in the Schedule hereto is hereby taken for soil conservation and river control purposes, and shall vest in the Waikato Valley Authority as from the date hereinafter mentioned; and I also declare that this Proclamation shall take effect on and after the 8th day of January 1976.

ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 3 of the Land Drainage Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. This order shall come into force on the day after the date of its notification in the *Gazette*.

2. The area described in the Schedule to this order is hereby included in the district of the Rotomanuka Drainage Board.
