Amending a Proclamation Taking Land for Works, Appliances, and Conveniences Necessary, Directly or Indirectly, for the Generation of Electricity in the Borough of Cromwell and the County of Vincent

DENIS BLUNDELL, Governor-General A PROCLAMATION

Pursuant to section 330a of the Public Works Act 1928, I, Sir Edward Denis Blundell, the Governor-General of New Zealand, hereby amend the Proclamation dated the 3rd day of August 1976, and published in New Zealand Gazette, No. 90, 12 August 1976, at page 1865, taking land for works, appliances, and conveniences necessary, directly or indirectly, for the generation of electricity in the Borough of Cromwell and the County of Vincent, pursuant to the Public Works Act 1928, and section 11 of the Electricity Act 1968, by omitting the Schedule and substituting the following Schedule.
