A PROCLAMATION

PURSUANT to subsection (6) of section 5 of the Education Lands Act 1949, I, Sir Edward Denis Blundell, the Governor-General of New Zealand, hereby proclaim and declare that the land described in the Schedule hereto, being an area vested in the Nelson Education Board as a site for a school, shall be vested in Her Majesty the Queen, freed and discharged from every educational trust affecting the same, but subject to all leases, encumbrances, liens or easements affecting the same at the date hereof.

ORDER

1. (i) This order may be cited as the Kaipara Pest Destruction District Abolition Order 1976.

(ii) This order shall come into force on the day after the date of its notification in the *New Zealand Gazette*.

2. The Kaipara Pest Destruction District, which was constituted by Order in Council on the 1st day of April 1971 (*New Zealand Gazette* on 7 April 1971, p. 618) is hereby abolished.

3. The assets and liabilities of the board, including any real or personal property, are hereby transferred to the Board of the Rodney County Pest Destruction District.
