1. (1) This order may be cited as the Waitakere Rural Fire District Order 1976. (2) This order shall come into force on the day after

its notification in the Gazette.

2. In this order, unless the context otherwise requires the "Act" means the Forest and Rural Fires Act 1955, "District" means the Waitakere Rural Fire District.

PART I-CONSTITUTION OF THE WAITAKERE RURAL FIRE DISTRICT

3. The area, specified in the Schedule to this order, is hereby constituted and declared to be a rural fire district to be known as the Waitakere Rural Fire District.

4. The trees and other plants on lands, described in the Schedule to this order, are hereby specified as the property for the protection of which the district is constituted. 5. The period between the 1st day of September in any one year and the 30th day of April in the following year (both days inclusive) is hereby declared to be a fire season in the district.
