### DENIS BLUNDELL, Governor-General A PROCLAMATION

PURSUANT to the Public Works Act 1928, I, Sir Edward Denis Blundell, the Governor-General of New Zealand, hereby proclaim and declare that the land described in the Schedule hereto is hereby taken for housing purposes and shall vest in the Mayor, Councillors, and Citizens of the Borough of Mount Albert, as from the date hereinafter mentioned; and I also declare that this Proclamation shall take effect, on and after the 25th day of November 1976.
