Discontinuing Civil Jurisdiction at the Magistrate's Court at Kaikoura

WHEREAS by an instrument, dated the 15th day of December 1948, published in the *Gazette* on the 16th day of the same month at page 1542, the Borough of Kaikoura was appointed a borough in which a Magistrate's Court may be held for the exercise of civil jurisdiction:

Now, therefore, I, Sir Edward Denis Blundell, the Governor-General of the Dominion of New Zealand, acting pursuant to subsection (5) of section 4 of the Magistrate's Courts Act 1947, do hereby revoke the appointment of the Borough of Kaikoura, and do declare that this revocation shall take effect on and after the 1st day of December 1976.
