PURSUANT to the Public Works Act 1928, I, Sir Edward Denis Blundell, the Governor-General of New Zealand, hereby proclaim and declare that the land described in the Frist Schedule hereto is hereby taken for the Dunedin-Milton motorway, and the land described in the Second Schedule hereto is hereby taken for street diversion in connection with the Dunedin-Milton motorway.
