by section 52 of the Transport Act 1962. 3. The roads specified in the Second Schedule hereto are hereby declared to be 70-kilometres-an-hour speed limit areas for the purposes of regulation 27A of the Traffic Regulations 1956\*

4. The Traffic (Masterton Borough) Notice No. 1, 1975, dated the 10th day of April 1975<sup> $\dagger$ </sup>, under section 52 of the Transport Act 1962, and regulation 27 $\Lambda$  of the Traffic Regula-tions 1956<sup>\*</sup>, which relates to roads situated within Masterton Borough is hereby revoked.
