*Varying Determination by the Minister of Customs Under Section 121 of the Customs Act 1966*

PURSUANT to section 121 of the Customs Act 1966, the Minister of Customs hereby varies, in the manner set out in the Schedule hereto, the determinations made under the said section on the 24th day of October 1975 and published in the *Gazette* on the 13th day of November 1975 at pages 2546 and 2547.

SCHEDULE

PART II of the determination is amended at paragraph 4 (c), by omitting the words "Hub caps" and adding the words "Hub caps, hub centres, full wheel covers, wheel trim bands, wheel trim discs and wheel rimblishers."

This variation to the aforesaid determination will take effect on the 1st day of October 1976.
