##### SPECIAL ORDER CONSOLIDATING SPECIAL RATES

NOTICE is given that, at its meeting held on Tuesday, 15 June 1976, the Picton Borough Council passed the following resolution by way of special order.

"That the following resolution carried at the ordinary meeting of the Picton Borough Council held on the 27th day of April 1976, be and the same is hereby confirmed:

That, in pursuance and exercise of the power vested in it in that behalf by section 108A of the Municipal Corporations Act 1954, and all other powers in that behalf enabling it, the Picton Borough Council resolves so that this resolution may be confirmed at a subsequent meeting of the Council and operate as a special order, to make an annual recurring consolidated special rate upon the rateable value of all rateable property of the Borough of Picton comprising the whole of the Borough of Picton and that such consolidated special rate shall be made in substitution for the several special rates made in respect of the following special loans:
