PURSUANT to section 19 of the Urban Renewal and Housing Improvement Act 1945, I, Sir Edward Denis Blundell, the Governor-General of New Zealand, hereby proclaim the land defined in the Schedule hereto to be a reclamation area under Part II of the said Act; and I also declare that this Proclamation shall take effect on and after the 25th day of August 1976.
