The rights, powers, and privileges conferred by this Order in Council shall not apply to those portions of the foreshore required for securing the shore ends of any telegraph cables that are at present, or may be at any time laid down

cables that are at present, or may be at any time laid down within the said area of foreshore.

within the said area of foreshore. 4. The Board may enclose any part or parts of the foreshore, described in the First Schedule hereto, for the purpose of holding athletic sports or games and may, by bylaws, fix a charge for admission to such enclosed part or parts: Provided that the total number of days on which such enclosures are made shall not exceed 6 in any 1 year. 5. Nothing herein contained shall authorise the Board to remove, or cause to be removed, any stone, sand, shingle, or shells without the consent of the Minister being first obtained. 6. The Board may, subject to the provisions of section 178

6. The Board may, subject to the provisions of section 178 of the Harbours Act 1950, erect or license or permit the erection of bathing sheds, boat sheds, boat building sheds, jetties, or slipways on the foreshore described in the First Schedule hereto, and may make bylaws regulating the use thereof, and may fix charges for such use: Provided that the funds so received shall be expended in improving the foreshore for the benefit of the public.

Bylaws made by the Board under the authority of this Order in Council shall not come into force until they have been approved by the Minister, by notice in the *Gazette*. 8. The said rights, powers, and privileges may be at any time resumed by the Governor-General, without payment or any compensation whatever, on giving to the Board 6 calendar months' notice in writing. Any such notice shall be sufficient if given by the Minister and delivered at, or posted to, the last-known address of the Board in New Zealand.
