

Amending a Declaration Declaring Land Taken for Coal Mining Operations Under Part III of the Coal Mines Act 1925 in Block XI, Rangiriri Survey District, Raglan County

PURSUANT to section 330A of the Public Works Act 1928, the Minister of Works and Development hereby amends the Declaration dated the 9th day of February 1977, published in *Gazette*, No. 28, 10 March 1977, at page 564, declaring land taken for coal mining operations under Part III of the Coal Mines Act 1925, in Block XI, Rangiriri Survey District, Raglan County, pursuant to section 32 of the Public Works Act 1928, by omitting the Schedule and substituting the following Schedule:
