HUNUA RIDING

ALL that area in the North Auckland Land District, Franklin County, bounded by a line commencing at the northernmost corner of Allotment 97, Otau Parish, in Block XIII, Wairoa Survey District, and proceeding westerly along the northern boundary of Allotment 158 to and southerly along the generally western boundaries of that Allotment 158 to the southernmost corner of Allotment 88; thence north-westerly and south-westerly along the north-eastern and north-western boundaries of Allotment 89 to its westernmost corner, all the aforesaid allotments being of Otau Parish; thence westerly generally along the generally southern boundaries of Lot 13, D.P. 49440, and continuing along the northern boundary of Lot 2, D.P. 33851, and that boundary produced to the middle of the Wairoa River in Block XII, Wairoa Survey District; thence northerly down the middle of that river to a point in line with the northern boundary of Allotment 112A, Hunua Parish; thence westerly along a right line to and along the northern boundaries of that Allotment 112A and Allotment 112 and the

last boundary produced to the middle of the public road forming the western boundaries of Allotments 112 and 111; thence south-westerly generally along the middle of that road to and along the middle of the public road forming the north-western boundaries of Allotments 148, 149, 150, 249, 151, 175A, S. 175, N.W. 176, M. 176, and S.W. 176 to and westerly generally along the middle of the public road forming the generally northern boundaries of Allotment 177, to the southern boundary of Allotment 344; thence north-westerly along a right line to the intersection of the western boundary of that allotment with the right bank of Hays Stream and south-westerly generally along that right bank to the north-eastern boundary of Allotment 168; thence north-westerly along the north-eastern boundaries of Allotment 168 and that boundary produced to the middle of that public road forming the south-eastern boundaries of Allotments N. 171 and S. 171; thence south-westerly along the middle of that road and that middle line produced south-westerly to its intersection with the north-eastern boundary of Lot 3, D.P. 15356, in Block I, Opaheke Survey District; thence south-easterly along the north-eastern boundary of that Lot 3 to and westerly along the southern boundaries of that Lot 3; Lot 4, D.P. 15356; an area of closed road, Allotment 239 and Allotment 154, and the last boundary produced across Hays Stream to its left bank; thence northerly and south-westerly generally along the left bank of that stream to the northern side of Hunua Gorge Road; thence south-easterly generally along that northern side to and along the south-western boundary of an area of 3.9 perches, shown on S.O. plan 44280 (now public road) and its production for a distance of 87 links and along a right line bearing 227° 45' to and along the generally south-western boundary of part Allotment 52, shown on D.P. 3521; thence south-easterly along the south-western boundaries of that part Allotment 52 to and southerly along the western boundaries of that part Allotment 52 and Lot 1, D.P. 55769, Allotments 81 and 84, all the aforesaid allotments being of Hunua Parish and along a right line across Lot 1, D.P. 64288, a public road to and along the western boundaries of Lots 2 and 1, D.P. 28612, crossing the intervening public road to and along the western boundary of Lot 3, D.P. 55373, and Lot 1, D.P. 56836, to its westernmost corner; thence south-easterly along a right line across that Lot 1 and Lot 2, D.P. 56836, and Lot 2, D.P. 23539, to and along the north-eastern boundaries of Lots 3, 4, and 5, D.P. 57582, and Lots 7 and 6, D.P. 57032, to and south-westerly along the south-eastern boundaries of the aforesaid Lot 6 and Lot 5, D.P. 57032; Lots 65, 64, and 63, D.P. 119, to the northern boundary of Allotment 148, Opaheke Parish, in Block VIII, Drury Survey District; thence southerly and easterly along the northern boundaries of that Allotment 148, Lot 1, D.P. 46285, Lots 2 and 1, D.P. 41441; Lot 1, D.P. 19546; Allotment 225, the end of a public road, Lot 1, D.P. 21743, Allotment 199B, the end of a public road, Allotment 199A, the end of a public road, Allotment 192 and 120 to the left bank of the Mangawheau Stream; thence north-easterly generally along the left bank of that stream to a point in line with the middle of a public road forming the south-western boundary of Lot 1, D.P. 29575; thence south-easterly generally along a right line to and along the middle of the said public road to and along the middle of Allotment 306 (formerly public road) to and along the middle of a public road forming the generally north-eastern boundaries of Lot 3, Deeds Plan 49; Lot 97, D.P. 24763; Lot 1, D.P. 71773; Allotments 97, 201, 202, and the middle of the public road intersecting that Allotment 202, to and along the middle of a public road forming the generally north-eastern boundaries of Allotments 207, 208, and Lot 3, D.P. 35940, to a point in line with the northern boundary of Lot 3, D.P. 24929; thence easterly along a right line to and along the northern boundary of that Lot 3 and its production to the middle of a public road in Block X, Opaheke Survey District; thence southerly generally along the middle of that road which forms the eastern boundaries of that Lot 3 and Lot 2, D.P. 24929, and Allotment 117, all the aforesaid Allotments being of Opaheke Parish, and Allotment 258, Mangatawhiri Parish; Allotments 91 and 134, as shown on D.P. 7824, Mangatawhiri Parish; Lots 2 and 1, D.P. 52235; and Allotment 135, Mangatawhiri Parish, as shown on D.P. 11305, to and north-easterly along the middle of that road and Matheson's Road to a point in line with the northern boundaries of Allotment 114, Otau Parish; thence easterly along a right line to and along the northern boundaries of that Allotment 114 an area of crown land and Allotment 139 to and northerly and easterly along the western and northern boundaries of that Allotment 139 and easterly along the northern boundary of Allotment 140 to the northernmost corner of that Allotment 140 in Block VIII, Opaheke Survey District; thence north-easterly generally along the generally south-eastern boundaries of Allotments 126, 61, 59, 118, and the intervening 163, and Allotments 57, 55, 103, and the intervening 147, and Allotments 102, 148, and Lot 1, D.P. 29892, to its easternmost corner in Block XIV, Wairoa Survey
