

- (a) On every Monday, Tuesday, Wednesday, and Thursday (not being days when licensed premises are required to be closed for the sale of liquor to the general public, and not being Christmas Eve or New Year's Eve), the hour of opening and closing shall be in accordance with its charter.
- (b) On every Friday, Saturday, and Christmas Eve (not being days when licensed premises are required to be closed for the sale of liquor to the general public) the hour of opening shall be 11 o'clock in the morning and the hour of closing 11 o'clock in the evening.
- (c) On every New Year's Eve/New Year's Day (not being days when licensed premises are required to be closed for the sale of liquor to the general public) the hour of opening shall be 11 o'clock in the morning of New Year's Eve and the hour of closing 0.30 o'clock in the morning of New Year's Day.
- (d) This order is for 12 months only as from the date the extended hours come into effect.
