ELIZABETH R. A PROCLAMATION

PURSUANT to section 63B (1) of the Forests Act 1949 (as substituted by section 19 of the Forests Amendment Act 1976), and the Royal Powers Act 1953, We hereby set apart in the Nelson Conservancy the State forest land described in the Schedule hereto as a State forest park to be known as the Mount Richmond State Forest Park and direct that this Proclamation shall come into force on the 4th day of March 1977 1977.
